...where (Who) else would I be?...

Now every year his parents went to Jerusalem for the festival of the Passover. And when he was twelve years old, they went up as usual for the festival. When the festival was ended and they started to return, the boy Jesus stayed behind in Jerusalem, but his parents were unaware of this. Assuming that he was in the group of travelers, they went a day's journey. Then they started to look for him among their relatives and friends. When they did not find him, they returned to Jerusalem to search for him. After three days they found him in the temple, sitting among the teachers, listening to them and asking them questions. And all who heard him were amazed at his understanding and his answers. When his parents saw him they were astonished, and his mother said to him, "Child, why have you treated us like this? Your father and I have been anxiously looking for you." He said to them, "Why were you searching for me? Did you not know that I must be in my Father's house?" But they did not understand what he said to them. Then he went down with them and came to Nazareth and was obedient to them, and his mother treasured all these things in her heart.

This story of the adolescent Jesus provides two points where we may reflect on how our lives more closely model the life of the Christ. The first point is an encouragement to young parents.

Listen.... on days when you're feeling particularly low or wondering if you've got any game as a parent, or feeling wretched for the way some moment of parenting has gone, please remember that Mary and Joseph lost Jesus for 3 days. Yep. The persons tasked by Almighty God with raising His Incarnate Son got separated from the boy for three days! If the Blessed Mother and Saint Joseph can do *that*, it's quite likely that similar lapses, gaffes and errors will be a part of your experience as well. The Holy Family seems to have recovered nicely, and so will you.

This etiological story about Jesus tells us that at a very young age Jesus possessed intellectual acuity and an instinctive desire for the divine. So we might think His prescience is the second meditative point, and it would be a fine place to pause for prayer and self-examination. That's not the second point I'm imagining, though.

"Why were you searching for me? Did you not know that I must be in my Father's house"

This can be heard as the wise crack of an exasperating pre-teen smarty-pants Jesus; the scene as Luke creates it suggests such an interpretation. I think however there's a larger learning that describes more than the intellectual and spiritual development of children, or their being obedient to their parents, and/or parents being attentive to their children.

When Jesus asks "Why were you searching for me? Did you not know that I must be in my Father's house," He's not cracking wise. He's describing Himself. He is saying who He is by describing what He's doing. Now that, dear friends, is a dangerous thing to do, and I do not recommend it as an habitual way of identifying yourself. It's easy to blur the edges of identity when asked who you are, "I'm a plumber." Remember that while you are a person who is gifted as an architect or chef or harbor pilot, you are a person first - a person with a name whether the gifts are present or not. It is seductively easy to employ this imprecise/inaccurate method.... it's easy to identify oneself as the chief cook and bottle washer in the house instead of identifying yourself as Mary or Ralph. Please don't do that.

That said, we are free to see Jesus identify Himself by what He's doing in this particular moment. He's saying that He's doing what He knows; Jesus is reverting to type. He's saying that attending to the business of His faith by engaging His heart and mind truly is who He is. It is not simply what He does, it's who He is. When we understand that, we are invited to do the same.

The New Year is turning. It is a good time to ponder how is it that *you* revert most closely to type where God is concerned? What is *your* version of Jesus' question to His parents? Is it in relishing bible study? Is it in meditating upon the features and nature of Heaven? Is it the daily prayer that asks what God has in mind for you to know? Perhaps it's that point in the weekly Mass that you really look forward to - the phrase or moment that gives such comfort and strength and support? Or perhaps it's the reflexive simple utterance of gratitude for a good report from the doctor.

Jesus' response to His parents prompts our own question. Hopefully it is one that expresses the person we are and are becoming in Him. It's 2024; by what evidence do *you* know that your business is in your Father's house?

For all that has been, Thanks. For all that will be, Yes.

Using Your Contributions to Lower Your Taxes



At the end of every calendar year, many people determine that additional donations to Christ Church would be advantageous for tax purposes. If you are one of those people, please ensure that your contributions are dated no later than December 31, 2023, and received by January 5, 2024. This way, we will be able to include them in your 2023 Contributions Statement. If contributions come in later than January 5, 2024, they will be accredited to 2024.

Additionally, please be aware that IRA owners age 70½ or over have an option to transfer up to \$100,000 to charity tax-free each year. These transfers, known as Qualified Charitable Distributions or QCDs, offer eligible older parishioners a great way to easily give to Christ Church before the end of the year.

Moreover, for those who are at least 72, QCDs count toward the IRA owner's Required Minimum Distribution (RMD) for the year.

Treasurer's Report

2023 has been a very good, though not great, year financially for Christ Church Parish-Kent Island.

The deficit, which was projected to be some \$95,000, is about half of that amount. That is wonderful news! And, as can be seen in the accompanying numbers, the explanation for this heartening development is the tremendous increase in giving from you, the members of the church. Through the end of November (and with a month yet to go in the budget year), we have surpassed the total contributions that the budget makers hoped could be raised in 2023-in fact, in every phase of revenues, save Miscellaneous Income, we are performing better than expected.

Also, as can be seen by the accompanying financials, the church leadership has done a good job controlling expenses, so we have spent less than anticipated.

Finally, as can be seen in the Mortgage Fund report, our outstanding mortgage is \$115,490. This year to date, we have paid down the principal by almost \$125,827, a truly remarkable achievement. In part, this was due to the 40/10 Campaign, which was initiated by and spearheaded both financially and inspirationally by Father Mark Delcuze. We now face the very real possibility that the mortgage will be paid off in early 2025, a dream that Father Mark long cherished.

For this good news, I would personally like to thank the staff, especially Bookkeeper Jean Travis and Parish Administrator Brenda Faulkner, the leadership of the church, particularly Senior Warden Lois Vanderbok, Junior Warden Warren Pender, the head of the Stewardship Committee, Charlie Mead, the Vestry, and most especially the Finance Committee, whose dedicated and tireless members: Cary Gates (Chair), Richard Sells, Bob Thompson, Laurelle McCready, and Dave Ellwood did much to put the church in the strong place it finds itself financially.

So, with all this good news, why the qualification in the first sentence that this was a very good but not great year financially? That is because we are still running a deficit; are still using money from the endowments to finance church operations; and are still deferring some needed capital improvements. My hope is that the

excellent Stewardship Campaign we have enjoyed will make it possible to narrow, and maybe even eliminate, that deficit so that next year there will be no qualification in my year-end review.

BACKPACK WEEKEND MEALS FOR KIDS WE ARE BLESS AND VERY, VERY GRATEFUL!

Every week during the school year, Christ Church and community volunteers gather on Thursday mornings to prepare, pack and deliver 175 bags of weekend food for food-insecure children in three schools. During the summer we support the QACPS Migrant Program and summer school sessions at the four Title I schools.

By the end of 2023, 25 energetic volunteers will have helped to plan for, prepare and deliver about 6,000 bags of weekend food to children in need.

Christ Church is part of a coalition of 10 churches that provide weekend meals for 630 children in every elementary and middle school in the county. We help coordinate the county-wide program and serve as a hub for delivery of Maryland Food Bank supplies used by the churches. The program is partially funded by Queen Anne's County and the churches provide the rest.
