

Choral Intern Program at Christ Church, Kent Island

Purpose: The purpose of the Choral Intern program is threefold. First, it provides an opportunity for a young singer to experience the rich world of choral music and to gain valuable experience as a chorister. Second, it provides additional choral and musical support within our Parish Choir to enrich the worship services. And third, it increases our outreach and presence within the local community.

Benefits: The Choral Intern will gain experience in choral singing, sight-reading, and section leadership. The Intern will receive coaching from the Minister of Music. As desired and appropriate, the Intern will be given opportunities to conduct the choir, present solos, and/or lead music from the organ or piano.

Requirements: The Choral Intern is expected to be professional and respectful to other choir members. There is no religious expectation for the Intern; singers of all faiths are welcome to apply. The Choral Intern should have a pleasant voice and at least basic sight-reading ability. The Intern should have previous experience singing as part of an ensemble and be a junior or senior in high school, or in college.

Schedule: The Internship will be for one academic year (September-May). The Intern will be expected to attend 30 prescheduled events, made up of Sunday morning (9:15 a.m. – 12:30 p.m.) services and rehearsals and Christmas Eve services, Holy Thursday, and Easter services. The Choral Intern will prepare for rehearsals by learning their parts ahead of time.

Note: With prior approval by the Minister of Music, up to two absences may be excused.

Stipend: Christ Church will provide a \$2000 stipend to the Choral Intern, subject to appropriate local, state, and Federal taxes. The stipend will be paid in two installments (December and May). If the Intern is absent for more than the two excused absences, the stipend may be reduced by \$72 per missed event.

Supervision: The Choral Intern reports to the Minister of Music.

Application: Interns will need to submit an application form, including contact information for a reference from their school music teacher, and an audio recording of themselves singing a solo piece of music. This may be accompanied or *a capella*. Art songs are preferred, but applicants may also submit a recording of a hymn or Broadway solo. Pop songs are not acceptable.
